

Refund of Charges – Fall 2020

Definitions for purposes of this section:

- a)“ Official withdrawal” means the student’s timely and complete execution of documents required by a college to accomplish formal removal from, as appropriate to the context, the college or its course(s), residence and/or meal plan; and
- b)“ Unofficial withdrawal” means any absence without the notice required for an official withdrawal.

Official withdrawal from a course between 4 and 5 business days of the semester’s first day of classes	September 3– September 4, 2020	50% of each dropped course
Official withdrawal after 5 business days of the semester’s first day of classes	September 5, 2020 and forward	0% of each dropped course
Unofficial withdrawal at any time	N/A	0% of each dropped course
